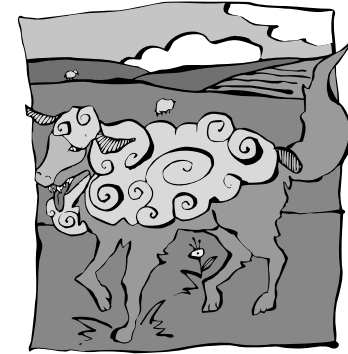

Domestic abuse occurs in one-out-of-four families and we who serve as shepherds in our churches need to be ready to protect the victims. The problem is that Domestic Violence is a hidden crime. Abusers and their victims put on a convincing face in public...a face that says, “Everything is alright. Everything is as it should be,” but the hidden truth will shock you.

- *How can we, as shepherds in the faith community, spot the hidden crime of Domestic Violence?*
- *What do I do once I've identified the problem?*
- *How do I deal with the offender?*
- *How can I help the victims?*
- *How can we prevent domestic violence in the first place?*
- *What does the Bible say about all of this?*

There are answers....

Pastors and ministry leaders can feel very much alone and ill-equipped when dealing with such horrific problems in the lives of those whom we care about and are called to protect.

But we are not alone and God has equipped us. God has also established the authorities to partner with us to see that both justice and healing are carried out. We can fight this battle together and see victory in the lives of both victims and offender alike.
